WHEREAS, the Virginia Railway Express (VRE) Master Agreement requires the Potomac and Rappahannock Transportation Commission (PRTC) and the Northern Virginia Transportation Commission (NVTC) to approve the annual budget of the VRE and forward it to the participating jurisdictions with a request to budget and appropriate their respective shares of the capital and operating costs of VRE; and

WHEREAS, Prince William County will fund its FY19 VRE subsidy totaling \$6,183,745 from the Northern Virginia Transportation Authority (NVTA) 30% local distribution funds instead of from motor fuel tax funds; and

WHEREAS, the City of Manassas will fund \$450,000 of its FY19 VRE subsidy of \$785,898 from City funds with the remainder coming from motor fuel tax funds; and

WHEREAS, drawdowns for the PRTC member jurisdictions will be made for payment to VRE on July 2, 2018 and January 2, 2019, from the motor fuels tax revenues as indicated by the participating jurisdictional breakdown as follows; and

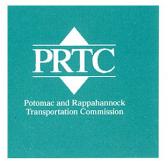

Recommendation:

Authorize the draw down from motor fuels tax funds to subsidize the VRE operating and capital budget for FY19.

Background:

The Virginia Railway Express (VRE) Master Agreement requires the Potomac and Rappahannock Transportation Commission (PRTC) and the Northern Virginia Transportation Commission (NVTC) to approve the annual budget of the VRE and forward it to the participating jurisdictions with a request to budget and appropriate their respective shares of the capital and operating costs of VRE.

Prince William County will fund its FY19 VRE subsidy totaling \$6,183,745 from the Northern Virginia Transportation Authority (NVTA) 30% local distribution funds instead of from motor fuel tax funds. The City of Manassas will fund \$450,000 of its FY19 VRE subsidy of \$785,898 from City funds with the remainder coming from motor fuel tax funds. The City of Manassas Park is slated to approve its FY19 VRE subsidy at its June 19, 2018 City Council meeting. The certified resolutions from the other PRTC member jurisdictions approving the drawdown from motor fuels tax funds for the FY19 VRE subsidies are attached.

Fiscal Impact:

Drawdowns for the PRTC member jurisdictions will be made for payment to VRE on July 2, 2018 and January 2, 2019, from the motor fuels tax revenues as indicated by the participating jurisdictional breakdown as follows:

This is an increase over the prior year's funding by \$285,000, which provides for an additional classroom to serve six more students. Should the expansion not occur, the funds may be appropriated to address the need in other ways. The Public Day School program provides educational services in the least restrictive, most cost-effective environment, within the community, through shared responsibility between the County and Schools for Public Day School students; and

BE IT FURTHER RESOLVED that the County Administrator is authorized to disburse funds to Stafford County Volunteer Fire and Rescue companies only after ensuring compliance with the Fire and Rescue Department, County, and State policies, regulations, rules, and procedures; and

WHEREAS, the Council of the City of Manassas has determined that it is appropriate to pay for PRTC administration, PRTC marketing, local capital match, parking lot leases, debt service on the Virginia Railway Express (VRE) parking deck, PRTC Omnilink services, and VRE services with its Gas Tax Funds; and

WHEREAS, the PRTC administration and City staff project that City Gas Tax funds will not be sufficient to cover the above expenditures and, therefore, the Council of the City of Manassas has determined that it is necessary to utilize City funds in the amount of \$450,000 to meet its obligation of \$785,898 for VRE Services; and

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Manassas, Virginia, meeting in regular session this 14th day of May, 2018, that:

<u>Section 1.</u> PRTC is authorized to appropriate \$998,898 from the City's Gas Tax funds for:

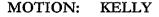
