Recommendation:

Ratify action of the Executive Director to provide letters of support for proposed regional transportation projects.

Background:

The Potomac and Rappahannock Transportation Commission (PRTC) was asked by Arlington County and the Fredericksburg Area Metropolitan Planning Organization (FAMPO) to provide a letter of support which would be included in their respective grant applications for their proposed regional transportation projects. The proposed projects are consistent with PRTC's goal of increasing transportation options. Due to a February 1, 2021 grant application deadline, it was not possible to seek Commission approval in advance.

Arlington County's proposed enhanced Transportation Demand Management project includes public outreach and marketing various transportation options, including PRTC's vanpool program.

The FAMPO proposed project is an intraregional multimodal east-west mobility study. With a focus on east-west movements, the goal of the study is to identify additional transportation choices, improve transportation network efficiencies, and connect different modes of transportation where possible across the region.

Please accept this letter in support of the Commuter Choice 395 proposal from Arlington County for Fiscal Year 2022. Consistent with the Commuter Choice Recipient Handbook (November 2020) sections 2.2.2.6 and 3.2.1, we are writing with our support as a third party that would be involved in the implementation of Arlington County's program. We consulted with Arlington County staff in the formulation of two separate but highly complementary grant activities: PRTC will allocate direct subsidies to vanpool riders when they register with them, and Arlington's business to business outreach and marketing team would conduct a corridor-level marketing program, raise awareness, recruit riders and direct them to PRTC's subsidy program, as well as provide PRTC with the necessary information about vanpool parking pricing at Arlington destinations in order for them to implement an effective parking subsidy as well.

These mutually supportive grants take best advantage of the strengths of each organization in order to maximize the uptake of vanpooling in the corridor, bringing the benefits of faster moving travel, more person throughput, and safer vehicles to the toll payers on the I-395 corridor.
